THE PORTSMOUTH CITY COUNCIL (CONSOLIDATION) (ON-STREET PARKING PLACES AND RESTRICTIONS ON WAITING AND LOADING) (NO.1) ORDER 2019

22 May 2019: Notice is hereby given that the Portsmouth City Council made the above Order under Sections 1, 2(1) to (3), 4(2), 32(1), 35(1), 45, 46, 49 and 124(1)c, (d) and (f), of the Road Traffic Regulation Act 1984 (“the 1984 Act”) as amended, the Traffic Management Act 2004 (“the 2004 Act”), and of all other enabling powers and after consulting the Chief Officer of Police for the County of Hampshire in accordance with Part III of Schedule 9 to the 1984 Act.

The effect of this Order, which will come into operation on **3 June 2019**, is to consolidate into one Order the existing on-street parking Traffic Regulation Orders. The parking restrictions remain unchanged on-street. The Orders to be consolidated are as follows:
