**THE PORTSMOUTH (NO.1 - (2019: ADDITION OF A RESTRICTED BYWAY)) DEFINITIVE MAP MODIFICATION ORDER 2019**  
**WILDLIFE AND COUNTRYSIDE ACT 1981**

This Order is made by Portsmouth City Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the Portsmouth City Council Definitive Map and Statement require modification in consequence of the occurrence of an event in section 53(3)(c)(i), namely, that a right of way which is not shown in the map is reasonably alleged to subsist over land in the area to which the map relates, being a restricted byway around the quayside of the Camber, Portsmouth.

The authority have consulted with every local authority whose area includes the land to which the order relates. Portsmouth City Council hereby order that:

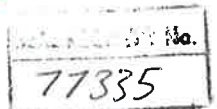
1. For the purposes of this order the relevant date is 18 July 2016.
2. The Portsmouth City Council Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This order shall take effect on the date it is confirmed and may be cited as the THE PORTSMOUTH (NO.1 - (2019: ADDITION OF A RESTRICTED BYWAY)) DEFINITIVE MAP MODIFICATION ORDER 2019.

### PART I

#### Modification of Definitive Map Description of way to be added

The addition of a restricted byway from (462981, 99518) Trimmer's Court at junction with East Street, proceeding northwards round quayside edge, progressing south along water's edge to the Bridge Tavern, turning west along inner Camber basin quayside edge to southern end of Trimmer's Court (462987, 99484) to a width of 3 metres as shown on the attached plan, with the green dashed line representing the centre-point of the restricted byway.

### PART II

#### Modification of Definitive Statement Variation of particulars of way

The addition of a restricted byway from (462981, 99518) Trimmer's Court at junction with East Street, proceeding northwards round quayside edge, progressing south along water's edge to the Bridge Tavern, turning west along inner Camber basin quayside edge to southern end of Trimmer's Court (462987, 99484) to a width of 3 metres as shown on the attached plan, with the green dashed line representing the centre-point of the restricted byway.
