Introduction

The Pride in Place Programme is committed to protecting your personal data and respecting your privacy. This privacy statement explains how we collect, use, store and protect your information when you engage with the programme.

Who We Are

The Pride in Place Programme's Accountable Body is Portsmouth City Council delivered by two Neighbourhood Chairs, working with the communities of Landport and Paulsgrove. Both chairs are local priests attached to churches within the respective communities.

We are the data controller for the purposes of UK data protection law.

What Information We Collect

We may collect and process the following types of personal data:

- Name
- Contact details (email address)
- Information relating to your participation in activities, events or consultations
- Feedback, survey responses or evaluation data
- Photographs or videos (with your consent)

How We Use Your Information

We use your information to:

- Administer and deliver the Pride in Place Programme
- Communicate with you about events, activities and opportunities
- Monitor and evaluate the programme's impact
- Meet reporting and funding requirements
- Improve our services and community engagement

We will only use your data for the purposes it was collected for, or for closely related purposes.

Lawful Basis for Processing

Under UK GDPR, our lawful bases for processing personal data include:

- **Consent** – where you have given clear permission
- **Legitimate interests** – where processing is necessary to deliver and improve the programme
- **Legal obligation** – where we are required to comply with law or funding requirements

You can withdraw your consent at any time.

Special Category Data

Any equality or diversity information is treated as **special category data**. We collect this only where necessary, keep it secure, and use it in an anonymised or aggregated form wherever possible.

How We Store and Protect Your Data

We take appropriate technical and organisational measures to protect your personal data, including:

- Secure digital storage systems
- Restricted access to information
- Staff training on data protection

We only keep your data for as long as necessary for the purposes outlined in this statement.

Sharing Your Information

We do **not** sell your personal data. We may share information with:

- Delivery partners involved in the programme
- Funders, in anonymised or aggregated form
- Service providers who support our operations (e.g. IT systems)

All third parties are required to handle your data securely and lawfully.

Your Rights

You have the right to:

- Access your personal data
- Request correction of inaccurate data
- Request deletion of your data
- Object to or restrict processing
- Withdraw consent at any time
- Lodge a complaint with the Information Commissioner's Office (ICO)
