**Portsmouth City Council (Portsmouth Water Mains Replacement) (Temporary Prohibition of Driving, Loading and Waiting) (No.103) Order 2018**

Notice is hereby given that Portsmouth City Council intends to make the above Order under Section 14(1) (a) of the Road Traffic Regulation Act 1984, as amended by the Road Traffic (Temporary Restrictions) Act 1991.

The Order comes into operation from **09<sup>th</sup> October 2018**. The works will be carried out in sections, the lengths and duration of which will be communicated by the placement of on-street signage and letters to residents prior to works taking place for each length or section of road(s). The effect will be as follows:-

**A) TEMPORARY PROHIBITION OF DRIVING**

<b>Warren Avenue</b> <b>29/10/2018- 09/11/2018</b>	Closed from the junction of Milton Road for access only. <b>Diversion:</b> Meon Road - Catisfield Road - Warren Avenue.
<b>Church View</b> <b>09/10/2018 – 19/10/2018</b>	Closed at junction with Milton Road. <b>Diversion for access:</b> via Meon Road, Catisfield Road, Warren Ave.
<b>Meon Road</b> <b>07/01/2019-18/01/2019</b>	Closed at junction Milton Road for access only. <b>Diversion:</b> Milton Road - Locksway Road - Crofton Road - Meon Road.
<b>Catisfield Road</b> <b>12/11/2018-15/12/2018</b>	Closed at junction Meon Road. <b>Diversion Northbound:</b> Meon Road - Hollam Road - Warren Avenue. <b>Diversion Southbound:</b> Warren Avenue - Crofton Road - Meon Road.  Closed at junction with Warren Avenue Exit onto Warren Avenue. Catisfield Road Entry from Meon Road <b>Diversion:</b> Catisfield Road Meon Road Hollam Road Warren Avenue

**B) TEMPORARY PROHIBITION OF LOADING AND WAITING**

<b>Warren Avenue</b>	Prohibition of waiting from the junction of Milton Road to Catisfield Road. No 1- 55 & 2 -64
<b>Blendworth Road</b>	Prohibition of waiting from Warren Avenue to Church View. No 1 – 17 & 2-14
<b>Catisfield Road</b>	Prohibition of waiting from Milton Road to Warren Avenue No 2-22 & 1-23

<b>Meon Road</b>	Prohibition of waiting from Milton Road to Hollam Rd 1-77a & 2-84
<b>Church View</b>	Whole Road – From Milton Road – Blendworth Road

**C) TEMPORARY PROHIBITION OF RIGHT TURN**

<b>Milton Road</b>	No Right Turn from or to Priory Crescent.
<b>Church View</b>	No Right & Left Turn from or to Milton Road.
<b>Priory Crescent</b>	No Right Turn from or to Milton Road.

**D) REASON FOR THE ORDER**

To facilitate installation of new water mains.

**E) DURATION OF THE ORDER**

From 09th Oct 2018 for 12 months or completion of the works, whichever is sooner? Notwithstanding the above it is expected that the closures will be in place for no longer than 12 months until 08<sup>th</sup> Oct 2019. On-street signage must be placed 14 days prior to works starting on each closure.

**F) DIVERSION**

See above under Roads or Street Names.
