

**THE PORTSMOUTH CITY COUNCIL (RESIDENTS PARKING PLACES)
(CONSOLIDATION) (NO. 1) ORDER 2020**

30 January 2020: Notice is hereby given that the Portsmouth City Council made the above Order under Sections 45, 51, 52, 53 and 124(1) (c), (d) and (f) of the Road Traffic Regulation Act 1984 (“the 1984 Act”) as amended, the Traffic Management Act 2004 (“the 2004 Act”), and of all other enabling powers and in accordance with Parts III and IV of Schedule 9 to the 1984 Act.

The effect of this Order, which will come into operation on **11 February 2020**, is to consolidate into one Order the existing residents' parking zone Traffic Regulation Orders. The parking restrictions remain unchanged on-street. The Orders to be consolidated are as follows:

STATEMENT OF REASONS FOR THE ORDER

To consolidate into a single Order the traffic regulation orders made since the last consolidation Order (9/2016). The parking restrictions in place on the public highway are unchanged by this Order.
