

THE PORTSMOUTH CITY COUNCIL (RESIDENTS' PARKING ZONES) (AMENDMENTS TO RESIDENTS' PARKING PLACES FOR SECURE CYCLE PARKING) (NO. 37) (PART B) EXPERIMENTAL ORDER 2022

The Portsmouth City Council, in exercise of its powers under Sections 9 and 10 of the Road Traffic Regulation Act 1984 ('the Act'), and of all other enabling powers, and after consultation in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:-

1. **This Order is an amendment** to The Portsmouth City Council (Residents' Parking Zones) (Amendments to Residents' Parking Places for Secure Cycle Parking) (No.37) Experimental Order 2021 which came into operation on the 15th March 2021 for a maximum period of 18 months.
2. This Order may be cited as The Portsmouth City Council (Residents' Parking Zones) (Amendments to Residents' Parking Places for Secure Cycle Parking) (No.37) (Part B) Experimental Order 2022.
3. Except where otherwise stated, any reference in this Order to a numbered Article or Section or Part or Schedule is a reference to the Article or Section or Part or Schedule bearing that number or letter in this Order unless otherwise stated.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
5. The Orders specified in Schedule 1 to this Order are hereby varied as specified in that Schedule.
6. The Director of Regeneration may modify or suspend this Order or any provision of it if it appears to him essential:-
 - (a) In the interests of the expeditious, convenient and safe movement of traffic;
 - (b) In the interests of providing suitable and adequate on-street parking facilities;
or
 - (c) For preserving or improving the amenities of the area through which any road affected by the Order runs.
7. The requirements, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any requirement, prohibition or restriction imposed by any regulations made or having effect as if made under the 1984 Act, or by any other enactment.


