

The Portsmouth City Council (Paradise Street) (Amendments to Waiting, Loading and Parking Places) (No. 31) Order 2022

The Portsmouth City Council, in exercise of the powers conferred by sections 1, 2, 4, 32, 35, 37, 45, 46, 49 and 124 of, and Parts III and IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other enabling powers, hereby makes the following Order:

Citation

1. This Order may be cited as The Portsmouth City Council (Paradise Street) (Amendments to Waiting, Loading and Parking Places) (No.31) Order 2022 and shall come into operation on the 25th March 2022.

General


2. Except where otherwise stated, any reference in this Order to a numbered Article or Section or Part or Schedule is a reference to the Article or Section or Part or Schedule bearing that number or letter in this Order unless otherwise stated.
3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. In this Order the expression “Principal Order” shall have the meaning of *The Portsmouth City Council (Consolidation) (On–Street Parking Places and Restrictions on Waiting and Loading) (No.1) Order 2021*.
5. Without prejudice to the validity of anything done, or to any liability incurred in respect of any act or omission before the coming into operation of this Order; this Order shall have the following effects:
 - (i) the items in Schedule 1 to this Order shall be inserted into the corresponding Schedules to the Principal Order.
 - (ii) where an item in a Schedule to this Order states in column 1 “*(substitutes item(s)...)*” it is to be interpreted that the item in the Schedule to this Order revokes and substitutes the corresponding item in the Principal Order.
 - (iii) where an item in a Schedule to this Order states in column 1 “*(revokes items(s)...)*” it is to be interpreted that the item in the Schedule to this Order is revoking the corresponding item in the Principal Order;
 - (iv) where an item in a Schedule to this Order states in column 1 “*(omits item(s)...)*” it is to be interpreted that the item in the Schedule to this Order is to be omitted in the Principal Order.
6. The provisions of the Principal Order shall apply to the areas designated as parking places by this Order as if in those provisions any reference to a parking place included a reference to an area designated as a parking place by this Order and as if any reference to the Schedule to the Principal Order included a reference to the Schedule to this Order.
7. The requirements, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any requirement, prohibition or restriction imposed by any regulations made or having effect as if made under the 1984 Act, or by any other enactment.

Schedule / Item	Road	Length of Road
Insert 1/1	Paradise Street	East side, from a point 4.5 metres north of its southern end in a northerly direction for a distance of 13.5 metres
Insert 1/2	Paradise Street	South side, from its north-west side in an easterly direction for a distance of 2 metres
Insert 1/3	Paradise Street	North-west side, from its southern end in a north-easterly direction for a distance of 15 metres

SCHEDULE 2

Substitution in Schedule 43 [TRO No.1/2021]

SCHEDULE 43 NO WAITING AND NO LOADING AT ANY TIME (EXCEPT WITHIN MARKED BAYS)		
Schedule / Item	Road	Length of Road
Substitutes 43/51	Paradise Street	North-west side, from a point 15 metres north-east of its southern end for its entire length except within the marked bays
		East side, from a point 18 metres north of its southern end for its entire length except within the marked bays

SCHEDULE 3

Omission and substitution in Schedule 48 [TRO No.1/2021]

SCHEDULE 48 LOADING ONLY		
Schedule / Item	Road	Length of Road
Omits 48/28(a)	Paradise Street	The southern end from its east side in a westerly direction for a distance of 8 metres
Substitutes 48/28(b)(i)	Paradise Street	North-west side from a point 28 metres north-east of its southern end in a north-easterly direction for a distance of 37 metres

Substitution in Schedule 87 [TRO No.1/2021]

SCHEDULE 87 DISABLED PERSONS' PARKING PLACES		
Schedule / Item	Road	Length of Road
Substitutes 87/28(b)	Paradise Street	The southern end from a point 2 metres east of its north-west side; bays angled 90° to kerb

Schedule / Item	Road	Length of Road
Substitutes 101/32	Paradise Street	North-west side from a point 15 metres north-east of its southern end in a north-easterly direction for a distance of 13 metres

This order is intended to adjust the positioning of the waiting and loading restrictions and parking places at the southern end of Paradise Street, to accommodate the footway being extended by 3 metres to improve pedestrian facilities to and from Arundel Street at the location.
