**THE PORTSMOUTH CITY COUNCIL (NO.1 - THE CAMBER (ADDITION OF A RESTRICTED BYWAY)) DEFINITIVE MAP MODIFICATION ORDER 2022**

This Order is made by Portsmouth City Council ("the Authority") under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the Secretary of State (who has directed the authority to that effect) that the Portsmouth City Council Definitive Map and Statement requires modification in consequence of the occurrence of an event in section 53(3)(c)(i), namely the discovery by the authority of evidence which (when considered with all other relevant evidence available to it) shows that a right of way that is not shown in the map and statement subsists or is reasonably alleged to subsist over land in the area to which the map relates, being a restricted byway to which this Part of the Act applies.

The authority has consulted with every local authority whose area includes the land to which the order relates.

**The Portsmouth City Council hereby orders that:**

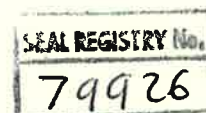
1. For the purposes of this order the relevant date is 01 April 2022.
2. The Portsmouth City Council Definitive Map and Statement shall be modified as described in Part I AND Part II of the Schedule and shown on the map attached to this Order.
3. This order shall take effect on the date it is confirmed and may be cited as the PORTSMOUTH CITY COUNCIL (NO.1 - THE CAMBER (ADDITION OF A RESTRICTED BYWAY)) DEFINITIVE MAP MODIFICATION ORDER 2022.

#### **Modification of Definitive Map Description of path or way to be added**

The addition of a restricted byway numbered 104 commencing at point A on the order plan (462981, 99518) at the junction of East Street with Trimmer's Court proceeding in a northerly direction for 60 metres to point B (462984, 99580) then turning to an easterly direction for 83 metres to point C (463068, 99581) then proceeding in a south easterly, southerly and south westerly direction for 118 metres to point D (463106, 99489) then turning to a westerly direction for 109 metres to point E (462999, 99467) where it turns to a north north-westerly direction for 22 metres to point F (462985, 99484) at Trimmer's Court at a width of 3 metres throughout. Total length 393 metres.

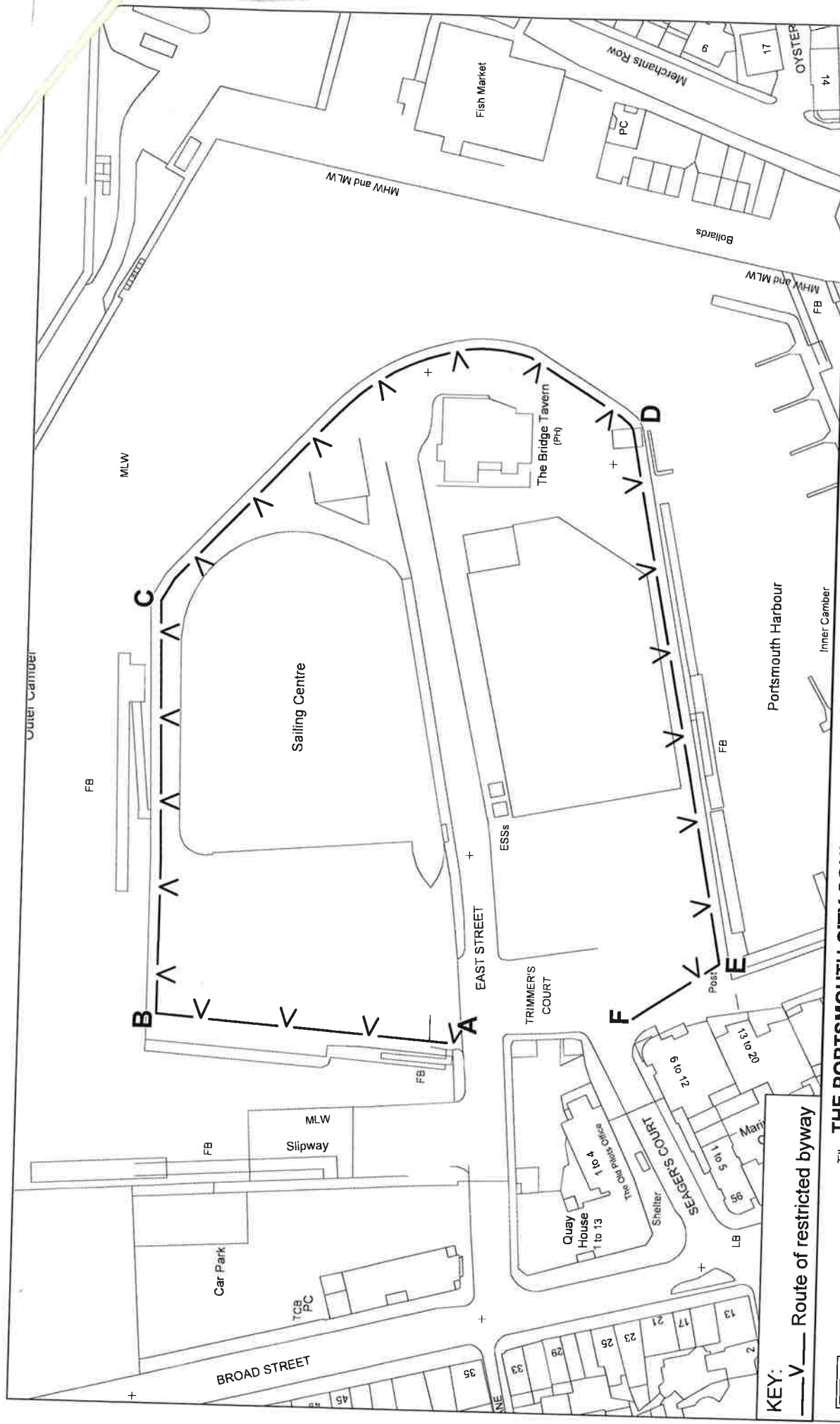
