

## **The Portsmouth City Council (London Road) (Taxi Rank) (No.87) Experimental Traffic Regulation Order 2022**

The Portsmouth City Council, in exercise of the powers conferred by Sections 9 and 10 of, and in accordance with Part III of Schedule 9 to, the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, and of all other enabling powers, hereby makes the following Order:

### Citation

1. This Order may be cited as The Portsmouth City Council (London Road) (Taxi Rank) (No.87) Experimental Traffic Regulation Order 2022 and shall come into operation on the 6<sup>th</sup> August 2022, for a maximum period of up to 18 months.

### Duration

2. This Order ceases to have effect 18 months after it comes into operation or when a further Order to reproduce and continue in force indefinitely the provisions of this Experimental Order is made, whichever is the easiest.
3. In pursuance of Section 10(2) of the 1984 Act, the Director of Regeneration or an officer of the Council to whom power has been duly delegated, may, if it appears to them or that person essential, modify or suspend this Order or any provision of it, without making an addition to the effect of the Order:
  - (a) in the interests of the expeditious, convenient and safe movement of traffic;
  - (b) in the interests of providing suitable and adequate on-street parking facilities; or
  - (c) for preserving or improving the amenities of the area through which any road affected by the Order runs;

### Interpretation

4. In this Order;
  - (i) "Principal Order" shall mean The Portsmouth City Council (Consolidation) (On-Street Parking Places and Restrictions on Waiting and Loading) (No.1) Order 2022
  - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
  - (iv) The requirements, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any requirement, prohibition or restriction imposed by any regulations made or having effect as if made under the 1984 Act, or by any other enactment.


### Amendments

5. The contents of Schedule 1 shall be inserted to the Principal Order as a new schedule 114B
6. A new Article shall be inserted to the Principal Order under Part IV, Section B to read as follows:  
"No person shall cause or permit any vehicle to stop or wait between the hours of 9am - midnight and midnight - 7am on any day, inclusive of bank holidays in the lengths of road specified in Schedule 114B, except if that vehicle is a taxi"
