

THE PORTSMOUTH CITY COUNCIL (LONDON ROAD) (TAXI RANK) ORDER 2024

The Portsmouth City Council, in exercise of its powers under Sections 1(1) and (2), 2(1) to (3), 4(2), 32(1), and 35(1) and (3) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

Citation

1. This Order may be cited as The Portsmouth City Council (London Road) (Taxi Rank) Order 2024 and will come into operation on the 27 January 2024.

Interpretation

2. In this Order;
 - (i) "Principal Order" shall mean The Portsmouth City Council (Consolidation) (On-Street Parking Places and Restrictions on Waiting and Loading) (No.1) Order 2022.
 - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
 - (iv) The requirements, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any requirement, prohibition or restriction imposed by any regulations made or having effect as if made under the 1984 Act, or by any other enactment.

Amendments

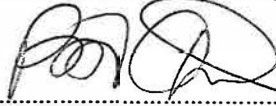
3. The following paragraph shall be inserted into the Principal Order under Part IV, Section B as a new Article:

"No person shall cause or permit any vehicle to stop or wait between the hours of 9am to midnight and midnight to 7am on any day, inclusive of bank holidays in the lengths of road specified in Schedule 114B, except if that vehicle is a taxi"
4. The contents of Schedule 1 shall be inserted into the Principal Order as a new schedule 114B.
5. The contents of Schedule 2 shall be deleted from Item 736 (c) in Schedule 1 to the Principal Order.
6. The contents of Schedule 3 shall be inserted into Item 736 (c) in Schedule 1 to the Principal Order.

SCHEDULE 1 - Insertion as a new Schedule 114B

No Stopping Except Taxis 9AM - Midnight and Midnight to 7am

Length of Road and Side of Length of Road

1. London Road

From 12 metres north of the northern kerbline of Laburnum Grove, northwards for 12 metres

SCHEDULE 2

No waiting at any time (deletion)

- (iv) from its junction with Laburnum Grove to its junction with Stubbington Avenue

SCHEDULE 3

No waiting at any time (addition)

- (iv) from the northern kerbline of Laburnum Grove northwards for 12 metres.
- (xiv) from a point 24 metres north of the northern kerbline of Laburnum Grove northwards to its junction with Stubbington Avenue
