

THE PORTSMOUTH CITY COUNCIL (FAWCETT ROAD) (LOADING BAY) ORDER 2024

The Portsmouth City Council (hereinafter referred to as “the Council”), in exercise of the powers under Sections 1, 2 and 124 of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, of all other enabling powers, after consultation with the Chief Office of Police in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

CITATION

1. This Order may be cited as The Portsmouth City Council (Fawcett Road) (Loading Bay) Order 2024 and shall come into operation on the 3 April 2024.

INTERPRETATION

2. In this Order:
 - (I) "Principal Order" shall mean Portsmouth City Council (Consolidation) (On-Street Parking Places and Restrictions on Waiting and Loading) (No. 1) Order 2022, as amended.
 - (II) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (III) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
 - (IV) The requirements, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any requirement, prohibition or restriction imposed by any regulations made or having effect as if made under the 1984 Act, or by any other enactment.

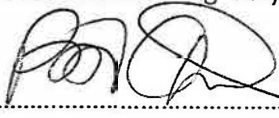
AMENDMENTS

3. The following paragraph shall be added as a new Article 7A to **PART II SECTION B of the Principal Order**:

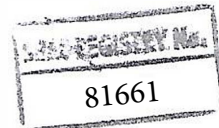
"No person shall cause or permit any vehicle to wait in the marked loading bays between the hours of 8am and 6pm, Monday- Saturday, including public holidays, specified in Schedule 48a except for the purposes of loading or unloading."
4. The contents of **Schedule 1** shall be deleted from **Schedule 70** to the Principal Order.
5. The contents of **Schedule 2** shall be inserted into **Schedule 70** to the Principal Order.
6. The contents of **Schedule 3** shall be inserted as a new **Schedule 48a** to the Principal Order.

**Waiting Limited To 1 Hour, No Return Within 1 Hour
Monday To Saturday 8am – 6pm (Deletion)**

9. FAWCETT ROAD

- (a) The east side;
 - (iii) from a point 9 metres south of its junction with Bramble Road to a point 10 metres north of its junction with Heyward Road

SCHEDULE 2

**Waiting Limited To 1 Hour, No Return Within 1 Hour
Monday To Saturday 8am – 6pm (Addition)**

9. FAWCETT ROAD

- (a) The east side;
 - (iii) from a point 9 metres south of its junction with Bramble Road to a point 16 metres north of its junction with Heyward Road

SCHEDULE 3

Loading Only Monday to Saturday 8am – 6pm (Addition)

1. FAWCETT ROAD

The east side from a point 10 metres north of its junction with Heyward Road in a northerly direction for a distance of 6 metres.
