

**THE PORTSMOUTH CITY COUNCIL (ON-STREET PARKING PLACES AND
RESTRICTIONS ON WAITING AND LOADING) (ISAMBARD BRUNEL ROAD)
(NO. 88) ORDER 2023.**

Portsmouth City Council in exercise of its powers under Sections 1, 2, 4 and 124 of the Road Traffic Regulation Act 1984, (the 1984 Act) as amended, the Traffic Management Act 2004 (the 2004 Act), and of all other enabling powers, after consultation with the Chief Constable of Police in accordance with Part III and IV of Schedule 9 to the 1984 Act hereby makes the following consolidation Order:

PART ONE - GENERAL

Commencement and Citation

1. This Order shall come into operation on 20 May 2024 and may be cited as The Portsmouth City Council (On-Street Parking Places and Restrictions on Waiting and Loading) (Isambard Brunel Road) (No. 88) Order 2023.

Definitions and Interpretation

2. In this Order, except where the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them:
 - (i) Principal Order means the Portsmouth City Council (Consolidation) (On-Street Parking Places and Restrictions on Waiting and Loading) (No. 1) 2022 as amended.
 - (ii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

General

3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
4. The requirements, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any requirement, prohibition or restriction imposed by any regulations made or having effect as if made under the 1984 Act, or by any other enactment.

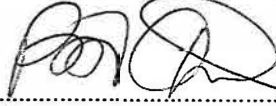
Amendments

 - (i) Substitute the item numbered 626 in Schedule 1 to the Principal Order with the item similarly numbered in Schedule 1 to this Order; and
 - (ii) Substitute the item numbered 18 in Schedule 48 to the Principal Order with the item similarly numbered in Schedule 2 to this Order.

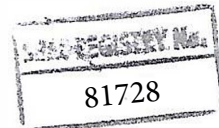

SCHEDULE 1

626. ISAMBARD BRUNEL ROAD

- a) East and north-east side, from its junction with Commercial Road to its junction with Winston Churchill Avenue.
- b) West and south-west side
 - (i) from its junction with Commercial Road to a point 10 metres south-east of the northern flank wall of Nos 4-6 Isambard Brunel Road.
 - (ii) from a point 22 metres south-east of the northern flank wall of Nos 4-6 Isambard Brunel Road to its junction with Winston Churchill Avenue.

SCHEDULE 2

18. ISAMBARD BRUNEL ROAD

- a) West and south-west side
 - (i) from a point 10 metres south-east of the northern flank wall of Nos 4-6 Isambard Brunel Road south-eastwards for 12 metres.
