

THE PORTSMOUTH CITY COUNCIL (HAVANT ROAD) (PARKING PLACES AND WAITING RESTRICTIONS) ORDER 2024

The Portsmouth City Council (hereinafter referred to as “the council”), in exercise of the powers under Sections 1, 2, 4 45, 46, 47 and 124 of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other enabling powers, and in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

Citation

1. This Order may be cited as The Portsmouth City Council (Havant Road) (Parking Places and -Waiting Restrictions) Order 2024 and shall come into operation on the 11 July 2024

Interpretation

2. In this Order :

Principal Order No 1 means the Portsmouth City Council (Consolidation) (On-Street Parking Places and Restrictions on Waiting and Loading) (No.1) Order 2022, as amended.

General

3. Except where otherwise stated, any reference in this order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this order.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
5. The requirements, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any requirement, prohibition or restriction imposed by any regulations made or having effect as if made under the 1984 Act, or by any other enactment.
6. The contents of Schedule 1 shall be deleted from Schedule 76 to Principal Order No 1
7. The contents of Schedule 2 shall be inserted into Schedule 76 to Principal Order No 1
8. The contents of Schedule 3 shall be inserted into Schedule 1 to the Principal Order 1

SCHEDULE 1

Delete from Schedule 1, Item 4. HAVANT ROAD

The south side from a point 63 metres east of its junction with Lower Drayton Lane to a point 10 metres west of its junction with Station Road

SCHEDULE 2

Insert in Schedule 1, Item 4. HAVANT ROAD

South side;

- i) From a point 63 metres east of its junction with Lower Drayton Lane to a point 41 metres west of its junction with Station Road
- ii) From a point 10 metres west of its junction with Station Road to a point 29 metres west of its junction with Station Road

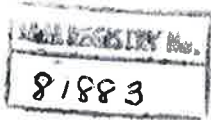
