

THE PORTSMOUTH CITY COUNCIL (LAKE ROAD) (WAITING RESTRICTIONS AND BUS LANE) (NO. 39)(PART 2) ORDER 2023

The Portsmouth City Council (hereinafter referred to as "the council"), in exercise of the powers under Sections 1, 2, 4 and 124 of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, the Traffic Management Act 2004 ("the 2004 Act), as amended, The Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022 and of all other enabling powers, and in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

Citation

1. This Order may be cited as The Portsmouth City Council (Lake Road) (Waiting Restrictions and Bus Lane) (No.39) (Part 2) Order 2023 and shall come into operation on the 24 July 2024.

General

2. In this Order:

Principal Order No 1 means the Portsmouth City Council (Consolidation) (On-Street Parking Places and Restrictions on Waiting and Loading) (No.1) Order 2022;

Principal Order No 2 means the Portsmouth City Council (Various Roads) (Bus, Taxi and Cycle Lanes and Prohibition of Driving Except Buses, Taxis and Cycles) (No.17) Consolidation Order 2016

3. Except where otherwise stated, any reference in this order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this order.

4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

5. The requirements, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any requirement, prohibition or restriction imposed by any regulations made or having effect as if made under the 1984 Act, or by any other enactment.

Waiting Restrictions

6. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order,

(a) the item numbered 683(a)(i) in Schedule 1 to Principal Order No 1 shall be substituted with the item similarly numbered in Schedule 1 to this Order;

(b) the item numbered 683(a)(v) in Schedule 1 to Principal Order No 1 shall be deleted

(c) the item numbered 25 (b) in Schedule 101 to Principal Order No 1 shall be substituted with the item similarly numbered in Schedule 2 to this Order.

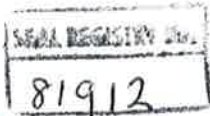
Bus Lanes

7. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the item numbered 10 in Schedule 1 to Principal Order No 2 shall be substituted with the item similarly numbered in Schedule 3 to this Order.

SCHEDULE 1

683 LAKE ROAD

- (a) (i) from its junction with Holbrook Road to a point 56 metres east of its junction with Spicer Street.

SCHEDULE 2

25. LAKE ROAD

The south side

- (a) from a point 11 metres east of its junction with Spicer Street in an easterly direction for a distance of 45 metres.

SCHEDULE 3

10. LAKE ROAD

- (a) Westbound, the area bounded by:
 - (i) the southern edge of the carriageway from its junction with Holbrook Road and a point 107 metres east of the eastern kerblines of Spicer Street, and
 - (ii) a single white line on the same side of the road as that edge.
- (b) Eastbound, the area bounded by:
 - (i) The northern edge of the carriageway from its junction with Fratton Road in a westerly direction for a distance of 105 metres, and
 - (ii) a single white line on the same side of the road as that edge.
