

THE PORTSMOUTH CITY COUNCIL (KING HENRY I STREET) (PARKING PLACE) ORDER 2024

The Portsmouth City Council (hereinafter referred to as "the council"), in exercise of the powers under Sections 1, 2, 4, 45, 46 and 124 of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, the Traffic Management Act 2004 ("the 2004 Act"), as amended, The Civil Enforcement of Road Traffic Contraventions (Approved Devices, Charging Guidelines and General Provisions) (England) Regulations 2022 and of all other enabling powers, and in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

Citation

1. This Order may be cited as The Portsmouth City Council (King Henry I Street) (Parking Place) Order 2024 and shall come into operation on the 23 May 2024.

Interpretation

2. In this Order:

"Principal Order " means the Portsmouth City Council (Consolidation) (On-Street Parking Places and Restrictions on Waiting and Loading) (No.1) Order 2022, as amended.

General

3. Except where otherwise stated, any reference in this order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this order.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
5. The requirements, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any requirement, prohibition or restriction imposed by any regulations made or having effect as if made under the 1984 Act, or by any other enactment.
6. The contents of Schedule 1 shall be deleted from Schedule 1 to the Principal Order
7. The contents of Schedule 2 shall be inserted into the Schedules to the Principal Order as detailed

SCHEDULE 1 Delete from Principal Order :

Delete Item 1, Schedule 37A to the Principal Order relating to No Waiting Except Taxis 8am - 5pm in King Henry I Street, North-east side, from the extended south-eastern kerbline of Spring Gardens, north-westwards for 15 metres

SCHEDULE 2 Insert into Principal Order1:

Amend Item 662(a)(i), Schedule 1 to the Principal Order, relating to no waiting at any time in King Henry I Street, northeast side to read:

'From the extended south-eastern kerbline of Spring Gardens, south-eastwards to a point 10 metres west of its junction with Guildhall Walk

Amend Item 9(b), Schedule 106 to the Principal Order, relating to Pay and Display in King Henry I Street to read:

'From 3 metres east of the extended eastern kerbline of Exchange Road, eastwards to the extended south-eastern kerbline of Spring Gardens'
