

THE PORTSMOUTH CITY COUNCIL (NORTH HARBOUR MEDICAL CENTRE) (PROHIBITION OF ENTRY AND ONE -WAY TRAFFIC) ORDER 2024

Portsmouth City Council, in exercise of its powers under Sections 1 (1), 2 (1) and (2), 124 (1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. Citation and Commencement

This Order shall come into operation on the **day of month 2024** and may be cited as "The Portsmouth City Council (North Harbour Medical Centre) (Prohibition Entry And One-Way Traffic) Order 2024".

2. Interpretation

In this Order except where the context otherwise requires, the following expressions have the meanings hereby respectively assigned them:-

"carriageway" means a way constituting or comprised in a highway being a way over which the public have a right of way for the passage of vehicles;

"enactment" includes any subordinate legislation within the meaning of the Interpretation Act 1978;

"pedal cycle" has the same meaning ascribed to it in the Traffic Signs Regulations and General Directions 2016.

"vehicle" means;-

- (i) A mechanically propelled vehicle intended or adapted for use on the road; and /or
- (ii) A pedal cycle in actual use for the purpose of cycling
- (iii) "vehicle", which shall for the avoidance of doubt include the whole or any part of a vehicle.

3. Except where otherwise stated any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.

4. The prohibitions imposed by this Order are in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption from the provision of this Order is without prejudice to the provisions of any other enactment.

5. Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment.

6. One-Way Streets

Save as provided in Article 7, no person shall drive or cause or permit to be driven any vehicle on the length of road specified in columns 1 and 2 of the Schedule otherwise than in the direction specified opposite that length in the third column of the said Schedule.

7. Exemptions

Nothing in Article 6 shall apply to:

- (a) a vehicle being used for at least one of the following purposes:
 - i) fire and rescue authority
 - ii) ambulance
 - iii) blood service

- iv) providing a response to an emergency at the request of an NHS ambulance service;
 - v) bomb or explosive disposal;
 - vi) special forces;
 - vii) police;
 - viii) National Crime Agency
 - ix) coastguard
- (b) any vehicle required to proceed in any road in accordance with any restriction or requirement indicated by traffic signs placed pursuant to section 67 of the Road Traffic Regulation Act 1984;
- (c) any mechanical road cleansing vehicle;
- (d) a vehicle being used for the purposes of:
- i) the maintenance, improvement or reconstruction of any length of highway specified in the Schedule;
 - ii) the laying, erection, alteration, repair or cleaning of any sewer, or of any main, pipe or apparatus for the supply of gas water, or electricity, or of any electronic communications apparatus, in any length of highway specified in the Schedule; or
- (e) anything done with the permission of or at the direction of a police constable in uniform.

SCHEDULE1

a) PROHIBITION OF RIGHT TURN

1. Northern Road

Vehicles not permitted to turn right into the Surgery Car Park.

b) PROHIBITION OF RIGHT TURN

2. St Georges Road

Vehicles not permitted to turn right from St Georges Road into Northern Road

SCHEDULE 2

a) "ONE WAY"FOR ALL TRAFFIC

1. St Georges Road

Direction of travel: from east to west

Length of road: from its junction with London Road to its junction with Northern Road.
