

THE PORTSMOUTH CITY COUNCIL (VARIOUS ROADS) (DISABLED PERSONS' PARKING PLACES AND WAITING RESTRICTIONS AMENDMENTS) (PO50-24)

Notice is hereby given that Portsmouth City Council on 30 October 2024 made the above Order under the Road Traffic Regulation Act 1984. The Order comes into operation on 1 November 2024, to effect:

A) To introduce Parking places for Disabled Persons (Minimum length 5 metres) in the following locations:

B) To remove Parking places for Disabled Persons' (no longer required) in the following locations

C) To amend the description of the existing "no waiting at any time" restriction on **Langstone Road south side between Milton Road and a point 3 metres west of the western boundary of No 2 Langstone Road, to align with the restriction as marked on the ground**

Any person wishing to question the validity of the Order or any of its provisions, on the grounds that it is not within the powers of the relevant enabling Act, or that a requirement of any such enabling Act or of any relevant regulations made thereunder has not been complied with, may, within 6 weeks from the date of the Order, make application for this purpose to the High Court
