

THE PORTSMOUTH CITY COUNCIL
(BOWLER AVENUE) (PARKING PLACES, WAITING RESTRICTIONS) ORDER 2024

The Portsmouth City Council (hereinafter referred to as “the council”), in exercise of the powers under Sections 1, 2, 4 45, 46, 47 and 124 of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, and of all other enabling powers, and in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

Citation

1. This Order may be cited as The Portsmouth City Council (Bowler Avenue) (Parking Places, Waiting Restrictions) Order 2024 and shall come into operation on the **26 November 2024**

Interpretation

2. In this Order :

Principal Order No 1 means the Portsmouth City Council (Consolidation) (On-Street Parking Places and Restrictions on Waiting and Loading) (No.1) Order 2022, as amended.

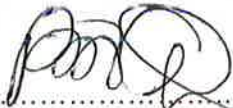
Principal Order No 2 means the Portsmouth City Council (Residents' Parking Places) (Consolidation) (No.1) Order 2022, as amended

General

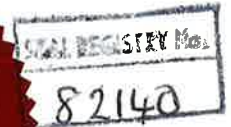
3. Except where otherwise stated, any reference in this order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this order.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
5. The requirements, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any requirement, prohibition or restriction imposed by any regulations made or having effect as if made under the 1984 Act, or by any other enactment.
6. The contents of Schedule 1 shall be deleted from Schedule 1 to Principal Order No 1.
7. The contents of Schedule 2 shall be inserted into Schedule 1 to Principal Order No 1.
8. The contents of Schedule 3 shall be deleted from Schedule 28 to Principal Order No 2.
9. The contents of Schedule 4 shall be inserted into Schedule 28 to Principal Order No 2.

Schedule No. 1

130. BOWLER AVENUE

- (c) The south and west sides from a point 2 metres north of its junction with Bowler Court to a point 6 metres east of that junction

Schedule No. 2

130 BOWLER AVENUE

- c) The south side
 - i) from the extended eastern kerb-line of Bowler Court eastwards for 6 metres
 - ii) from the extended western kerb-line with Milton road in a westerly direction for a distance of 2.5 metres
 - iii) from a point 20.5 metres west from the extended kerb-line with Milton road in a westerly direction for 2 metres

131 BOWLER COURT

- a) The east side:
From the southern kerb-line of Bowler Avenue for a distance of 3 metres in a southerly direction
- b) The west side: from the projected southern kerb-line of Bowler Avenue for a distance of 2 metres north

Schedule No. 3

- (b) The south side from its junction with Milton Road to a point 6 metres east of its junction with Bowler Court

SCHEDULE 28

RESIDENTS' PARKING PLACES

HA PERMIT HOLDERS

Or WAITING LIMITED TO 2 HOURS, NO RETURN WITHIN 4 HOURS

- a) The east side:
 - i) From a point 2.5 metres from the extended western kerb-line with Milton Road in a westerly direction for a distance of 20 metres
 - ii) From a point 22 metres from the extended western kerb-line with Milton Road in a westerly direction to a point 6 metres east of the eastern kerb-line of Bowler Court
