

**THE PORTSMOUTH CITY COUNCIL (VARIOUS ROADS)
(CYCLE PARKING PLACES) (PART 1) ORDER 2024**

The Portsmouth City Council (hereinafter referred to as "the Council"), in exercise of the powers under Sections 1, 2, 32, 35, 45 and 46 of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, of all other enabling powers, after consultation with the Chief Office of Police in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

CITATION

1. This Order may be cited as The Portsmouth City Council (Various Roads) (Cycle Parking Places) (Part 1) Order 2024 and shall come into operation on the 26 February 2025.

INTERPRETATION

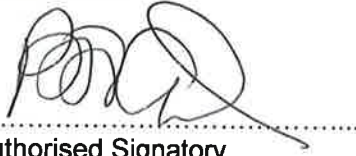
2. In this Order:
 - (I) "Principal Order 1" shall mean The Portsmouth City Council (Consolidation) (On-street Parking Places and Restrictions on Waiting and Loading) (No.1) Order 2022, as amended
 - (II) "Principal Order 2" shall mean The Portsmouth City Council (Residents' Parking Places) (Consolidation) (No.1) Order 2022, as amended
 - (III) "Principal Order No 3" shall mean The Portsmouth City Council (MD Zone Extension) (Residents' Parking Places and Waiting Restrictions) (No.124) Order 2022, as amended
 - (IV) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (V) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

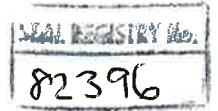
AMENDMENTS

SCHEDULE 1

28. ALLENS ROAD

- (a) Both sides from its junction with Waverley Road in an easterly direction for a distance of 5 metres
- (b) The north side from its junction with Welch Road in a westerly direction for a distance of 2 metres
- (c) The south side from its junction with Welch Road in a westerly direction for a distance of 3 metres

771 MALVERN ROAD

- (a) The west side;
- (ii) from its junction with Clarendon Road in a southerly direction for a distance of 9 metres

SCHEDULE 2

28 ALLENS ROAD

- (a) The north side
 - (i) from its junction with Welch Road in a westerly direction for a distance of 2 metres
 - (ii) from its junction with Waverley Road in an easterly direction for a distance of 5 metres
- (b) The south side
 - (i) from its junction with Welch Road in a westerly direction for a distance of 3 metres
 - (ii) from its junction with Waverley Road in an easterly direction for a distance of 8 metres

771 MALVERN ROAD

- (a) The west side;
- (ii) from its junction with Clarendon Road in a southerly direction for a distance of 12 metres

SCHEDULE 3

17. MALVERN ROAD

- (a) The west side;
- (i) from a point 9 metres south of its junction with Clarendon Road to a point 5 metres north of its junction with Villiers Road

SCHEDULE 4

17. MALVERN ROAD

- (a) The west side;
- (i) from a point 12 metres south of its junction with Clarendon Road to a point 5 metres north of its junction with Villiers Road

SCHEDULE 5

Allens Road

- (b) The south side;
- (i) from a point 5 metres east of its junction with Waverley Road in an easterly direction for a distance of 20 metres

SCHEDULE 6

Allens Road

(b) The south side;

(i) from a point 8 metres east of its junction with Waverley Road in an easterly direction for a distance of 17 metres
