

THE PORTSMOUTH CITY COUNCIL (KINGSTON ROAD) (BUS LANE AND WAITING RESTRICTIONS) ORDER 2025

The Portsmouth City Council (hereinafter referred to as "the Council"), in exercise of the powers under Sections 1, 2, 32, 35, 45 and 46 of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, of all other enabling powers, after consultation with the Chief Office of Police in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

CITATION

1. This Order may be cited as The Portsmouth City Council (Kingston Road) (Bus Lane and Waiting Restrictions) Order 2025 and shall come into operation on the **DATE**.

INTERPRETATION

2. In this Order:
 - (I) "Principal Order 1" shall mean The Portsmouth City Council (Various Roads) (Bus, Taxi and Cycle Lanes And Prohibition of Driving Except Buses, Taxis And Cycles) (No.17) Consolidation Order 2016, as amended
 - (II) "Principal Order 2" shall mean The Portsmouth City Council (Consolidation) (On-street Parking Places and Restrictions on Waiting and Loading) (No.1) Order 2022, as amended
 - (III) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (IV) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

3. The contents of Schedule 1 shall be added to Schedule 1 to Principal Order 1.
4. The contents of Schedule 2 shall be deleted from Schedule 1 to Principal Order 2.
5. The contents of Schedule 3 shall be added to Schedule 1 to Principal Order 2.
6. The contents of Schedule 4 shall be deleted from Schedule 23 to Principal Order 2.
7. The contents of Schedule 5 shall be deleted from Schedule 70 to Principal Order 2.
8. The contents of Schedule 6 shall be deleted from Schedule 76 to Principal Order 2.

SCHEDULE 1

Insert into Schedule 1 to Principal Order 1:

25. KINGSTON ROAD

- (a) Southbound, the area bounded by;
 - (i) The eastern edge of the carriageway from a point 25 metres south of the Binstead Road southwards for 9 metres, and
 - (ii) a single white line on the same side of the road as that edge.
- (b) Southbound, the area bounded by;
 - (i) The eastern edge of the carriageway from 10 metres south of Toronto Road southwards for 46 metres, and
 - (ii) a single white line on the same side of the road as that edge.
- (c) Southbound, the area bounded by;
 - (i) The eastern edge of the carriageway from 11 metres south of New Road southwards for 123 metres, and
 - (ii) a single white line on the same side of the road as that edge.

SCHEDULE 2

Delete from Schedule 1 to Principal Order 2, Item 471. FRATTON ROAD, (a) The east side;

- (ii) from its junction with St Mary's Road to a point 66 metres north of its junction with Hampshire Street

Delete from Schedule 1 to Principal Order 2, Item 669. KINGSTON ROAD, (b) The east side;

- (i) from a point 91 metres south of its junction with New Road in a southerly direction for a distance of 12 metres
- (ii) from a point 57 metres north of its junction with New Road to a point 17 metres south of that junction
- (iii) from a point 9 metres south of its junction with Toronto Road to a point 7 metres north of that junction

Delete from Schedule 1 to Principal Order 2, Item 669. KINGSTON ROAD;

- (c) The northeast side from a point 10 metres north-west of its junction with Binstead Road to a point 6 metres south-east of that junction

SCHEDULE 3

Insert into Schedule 1 to Principal Order 2, Item 471. FRATTON ROAD, (a) The east side;

- (i) From its junction with Kingston Road southwards to its junction with St Mary's Road.

Insert into Schedule 1 to Principal Order 2, Item 669. KINGSTON ROAD, (b) The east side;

- (i) from a point 7 metres north of its junction with Toronto Road southwards to its junction with Fratton Road

SCHEDULE 4

Delete from Schedule 23 to Principal Order 2;

16. KINGSTON ROAD

The east side from a point 57 metres north of its junction with New Road to a point 9 metres south of its junction with Toronto Road.

SCHEDULE 5

Delete from Schedule 70 to Principal Order 2, Item 17. KINGSTON ROAD;

(a) The east side;

- (i) from its junction with Fratton Road to a point 108 metres south of its junction with New Road
- (ii) from a point 7 metres north of its junction with Toronto Road to a point 6 metres south of its junction with Binsteed Road
- (iii) from a point 17 metres south of its junction with New Road in a southerly direction for a distance of 20 metres
- (iv) from a point 5 metres north of its junction with Little George Street in a northerly direction for a distance of 20 metres
- (v) from a point 1 metre south of its junction with Little George Street in a southerly direction for a distance of 20 metres

SCHEDULE 6

Delete from Schedule 76 to Principal Order 2;

2. FRATTON ROAD;

The east side from a point 66 metres north of its junction with Hampshire Street to its junction with Kingston Road
