

THE PORTSMOUTH CITY COUNCIL (VARIOUS ROADS) (DISABLED PERSONS PARKING PLACES) (No. 4) ORDER 2025

The Portsmouth City Council (hereinafter referred to as "the Council"), in exercise of the powers under Sections 1, 2, 32 and 35 of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, of all other enabling powers, after consultation with the Chief Office of Police in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

CITATION

1. This Order may be cited as The Portsmouth City Council (Various Roads) (Disabled Persons Parking Places) (No. 4) Order 2025 and shall come into operation on the **1 August 2025**

INTERPRETATION

2. In this Order:
 - (I) "Principal Order" shall mean The Portsmouth City Council (Disabled Persons Parking Places) (Consolidation) Order 2022, as amended
 - (II) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (III) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

3. The contents of Schedule 1 shall be deleted from Schedule 1 to the Principal Order
4. The contents of Schedule 2 shall be added to Schedule 1 to the Principal Order

Allcot Road	North	From a point 10 metres east of its junction with Copnor Road, for a distance of 5.5 metres in an easterly direction
Chichester Road	South	From the western property boundary of No.74, for a distance of 5.5 metres in an easterly direction
Clarendon Street	South-west	From the northern boundary of No.38, for a distance of 5 metres in a southerly direction
Essex Road	South	From the western boundary of No.33, for a distance of 5.5 metres in an easterly direction
Evans Road	South-west	From the western boundary of No.14, for a distance of 5 metres in an easterly direction
Gloucester Terrace	North-west	From the north-eastern boundary of No.11, for a distance of 5 metres in a south-westerly direction
Grange Road	East	From the northern boundary of No.7, for a distance of 5.5 metres in a southerly direction
Gruneisen Road	North	From the western closed end, for a distance of 5.5 metres in an easterly direction
Landguard Road	North	From the eastern boundary of No.50, for a distance of 5.5 metres in an westerly direction
Leominster Road	South	From the eastern boundary of No.149, for a distance of 5.5 metres in a westerly direction
Leominster Road	North	From a point 3 metres east of the western boundary of No. 160, for a distance of 5.5m in a westerly direction
Locarno Road	North	From the eastern boundary of No.57, for a distance of 5.5 metres in a westerly direction
Magdalen Road	North	From the western boundary of No.84, for a distance of 5.5 metres in an easterly direction
