1. Notice is hereby given that the Portsmouth City Council made the above Order on 8 August 2025. The effect of the Order will be:

At the following locations; to introduce one 6 metre length on-street "Electric Vehicle Charging Bays" (parking only for electric vehicles being re-charged). The EV bay will replace any existing control where appropriate;

4. This Order comes into operation on 30 September 2025.
