Notice is hereby given that the Portsmouth City Council proposes to make the following Order:
The Portsmouth City Council (Various Roads) (Disabled Persons Parking Places and Waiting Restrictions) (**P031-25**) Order 2025. The effect of the Order would be:

A) TO INTRODUCE DISABLED PERSONS' PARKING BAYS (MINIMUM 5-METRE LENGTH) IN THE FOLLOWING LOCATIONS:

Only vehicles displaying a Blue Badge or relevant permit issued by the Council may park at the following locations.
