

**THE PORTSMOUTH CITY COUNCIL (ZONE GB)
(RESIDENTS' PARKING PLACES) (AMENDMENT NO. 1) ORDER 2025**

The Portsmouth City Council (hereinafter referred to as "the Council"), in exercise of its powers under Sections 1, 2, 45, 46, and 124 of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, the Traffic Management Act 2004 ("the 2004 Act"), and of all other enabling powers and after consulting the Chief Officer of Police for the County of Hampshire in accordance with Part III and IV of Schedule 9 to the 1984 Act hereby makes the following Order:

CITATION

1. This Order shall come into operation on 24 October 2025 and may be cited as The Portsmouth City Council (Zone GB) (Residents' Parking Places) (Amendment No. 1) Order 2025.

GENERAL

2. In this Order the following expressions shall have the respective meanings assigned to them;
 - (a) "Principal Order" means The Portsmouth City Council (Zone GB) (Residents' Parking Places) (Consolidation) Order 2025.
3. Except where otherwise stated, any reference in this Order to a numbered Article or Section or Part or Schedule is a reference to the Article or Section or Part or Schedule bearing that number or letter in this Order.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
5. The requirements, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any requirement, prohibition or restriction imposed by any regulations made or having effect as if made under the 1984 Act, or by any other enactment.

AMENDMENTS

6. Article 2.3 of the Principal Order shall be deleted and replaced by the following:

"No person shall cause or permit any vehicle to wait on any day in the lengths of roads, and sides of lengths of road specified in Schedule 2 to this Order;

 - a) for a period longer than 4 hours; or
 - b) if a period of less than 4 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on those sides of roads or in those lengths of roads, or
 - c) unless the vehicle has a valid GB permit."
7. Article 2.4 of the Principal Order shall be deleted and replaced by the following:

"No person shall cause or permit any vehicle to wait on any day in the lengths of roads, and sides of lengths of road specified in Schedule 3 to this Order;

- a) for a period longer than 4 hours; or
 - b) if a period of less than 4 hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on those sides of roads or in those lengths of roads, or
 - c) unless the vehicle has a valid MI permit."
8. The title of Schedule 2 to the Principal Order shall be deleted and replaced by the following:

"GB PERMIT HOLDERS

OR

WAITING LIMITED TO 4 HOURS, NO RETURN WITHIN 4 HOURS "

9. title of Schedule 3 to the Principal Order shall be deleted and replaced by the following:

"MI PERMIT HOLDERS

OR

WAITING LIMITED TO 4 HOURS, NO RETURN WITHIN 4 HOURS "
