

**THE PORTSMOUTH CITY COUNCIL (VARIOUS ROADS)
(WAITING RESTRICTIONS) (No.6) ORDER 20**

The Portsmouth City Council (hereinafter referred to as "the Council"), in exercise of the powers under Sections 1, 2, 32, 35, 45 and 46 of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, of all other enabling powers, after consultation with the Chief Office of Police in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

CITATION

1. This Order may be cited as The Portsmouth City Council (Various Roads) (Waiting Restrictions) (No.6) Order 2024 and shall come into operation on the 24th of November 2025.

INTERPRETATION

2. In this Order:
 - (I) "Principal Order 1" shall mean The Portsmouth City Council (Consolidation) (On-street Parking Places and Restrictions on Waiting and Loading) (No.1) Order 2021, as amended.
 - (II) "Principal Order 2" shall mean The Portsmouth City Council (Residents' Parking Places) (Consolidation) (No.1) Order 2022, as amended.
 - (III) "Principal Order 3" shall mean The Portsmouth City Council (MG Zone: Festing Grove Area) (Residents' Parking Places and Waiting Restrictions) (No.49) Order 2022.
 - (IV) "Principal Order 4" shall mean The Portsmouth City Council (MH Zone Extension) (Residents' Parking Places, Waiting Restrictions and Amendments) (No.8) Order 2021.
 - (V) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (VI) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.
 - (VII) The requirements, prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any requirement, prohibition or restriction imposed by any regulations made or having effect as if made under the 1984 Act, or by any other enactment.

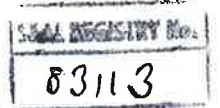

460 FORDINGBRIDGE ROAD

(c) The northeast side from its junction with Henderson Road in a northerly direction for a distance of 7 metres

3 ADAIR ROAD

(b) The west side;

(i) from the southern kerbline of Highland Road in a southerly direction for a distance of 10 metres

428 EXMOUTH ROAD

(a) the east side

(vii) from a point 20 metres south of its junction with Collingwood Road in a southerly direction for a distance of 3 metres

460 FORDINGBRIDGE ROAD

(c) The northeast side from its junction with Henderson Road in a northerly direction for a distance of 10 metres

(i) from a point 10 metres south of the southern kerbline of Highland Road in a southerly direction for a distance of 9 metres

SCHEDULE 7 - MH permit holders 6pm-8pm

2 FORDINGBRIDGE ROAD

(c) The northeast side from a point 7 metres north-west of its junction with Henderson Road in a north-westerly direction for a distance of 23 metres

SCHEDULE 8 - MH permit holders 6pm-8pm

(c) The northeast side from a point 10 metres north-west of its junction with Henderson Road in a north-westerly direction for a distance of 20 metres
