

Pre-submission version of the Legal Compliance Toolkit supporting the Pre-Submission Portsmouth Local Plan 2024 and Pre-Submission Local Plan Addendum 2025

December 2025



Introduction

The matters which are tested at a Local Plan examination are whether a Local Plan is legally compliant and sound. Local Planning Authorities should rigorously assess the plan before it is published under Regulation 19 to ensure that, in their view, it is sound and meets all the necessary legal requirements. Before submission of a Local Plan for examination, it can be helpful to carry out a self-assessment of the soundness and legal compliance of the Plan, although this is not compulsory.

Portsmouth City Council (PCC) carried out a self-assessment of how the Pre-submission Portsmouth Local Plan (PLP) 2024 met the legal requirements and tests of soundness in July 2024. This document is an updated self-assessment of the legal compliance of the PLP 2024 and the PLP Addendum 2025 at Pre-Submission (Regulation 19). This document sets out the Council's legal compliance self-assessment using the Planning Advisory Service¹ Local Plan Route Mapper & Toolkit - Oct 2021, which has been updated by the Council to account for recent changes in the planning system, such as the National Planning Policy Framework (NPPF) update in December 2024. The completed soundness self-assessment is covered in a separate document².

The Portsmouth Pre-Submission Local Plan 2024 was prepared in accordance with the version of the NPPF published in December 2023 and published for consultation in summer 2024. Since the publication of the Pre-Submission PLP 2024, PCC decided to prepare a Local Plan Addendum including a version of Policy PLP3: Tipner West that has no adverse impact on internationally designated sites that cannot be mitigated. A number of other policies have also been updated for the following reasons:

- They were impacted by the decision to avoid adverse impacts on international conservation designations that could not be mitigated
- The amount and/or type of development had changed independently of the decision regarding international conservation designations
- They were impacted by the new 2024 NPPF and the need to take account of the latest evidence.

The policies in the Pre-Submission PLP Addendum 2025 have been prepared in accordance with the version of the NPPF published in December 2024. The Addendum is the subject of a focussed Pre-Submission consultation in winter 2025. All references to the NPPF in this document are to the December 2024 version unless noted otherwise.

Table 1 summarises the timetable for production for the Portsmouth Local Plan to the point of submission, as set out in the Local Development Scheme³. This was approved by the City Council on 30 April 2025. It will be referred to within the following Checklist.

As the PLP 2024 and the PLP Addendum 2025 have reached Pre-Submission stage (Regulation 19), this checklist has been completed up until Question 63 of Stage F and is up to date as of December 2025. Questions 64 - 71 of Stage F will be updated at the appropriate time in the process as the Local Plan progresses through to Regulation 22.

TOOLKIT PART 3: LOCAL PLAN PROCESS REQUIREMENTS CHECKLIST

Why you should use this part of the toolkit

The aim of this part of the toolkit is to assist you in ensuring that the relevant process requirements of specific legislation and policy have been met to enable you to proceed towards adoption of a local plan policies update.

The part of the Toolkit deals only with the process requirements for plan preparation set out in legislation and the NPPF associated with reviewing policies and updating local plan policies. Toolkit Part 1 provides more detail on carrying out a local plan policy review assessment. Toolkit Part 2 highlights the content that should be included in the local plan policies update as prescribed in the NPPF. Soundness and quality issues are dealt with in Toolkit Part 4.

How to use this part of the toolkit

The table below sets out key plan making process questions that you must consider when undertaking the stages of reviewing policies and updating your local plan policies. The rows marked:

- 'L' set out legal requirements included in legislation relevant for that stage of plan making; and
- 'PM' highlight project management reminders arising from these requirements.

For each requirement the table also highlights, where relevant, the supporting documents in which this information is typically recorded.

For each of the requirements listed indicate whether you have met the requirement with a *Yes* or *No*. You should ensure you can answer each question relevant to that plan stage with a 'Yes' before moving to the next stage of updating your plan. You can use the 'comments' section in the table to confirm the title and date of relevant documents and include hyperlinks to where they are published on your website (or file paths for documents not yet published).

The following abbreviations in the table are used:

P&CA - [Planning and Compulsory Purchase Act 2004 \(as amended\)](#)

T&CP - [The Town and Country Planning \(Local Planning\) \(England\) Regulations 2012 \(as amended\)](#)

The table does not make any reference to specific national planning policy guidance, case law or Ministerial Statements on the basis that this is not static and the degree to which it is relevant will vary depending upon particular circumstances. There is case law relevant to most plan

making authorities; for example at the time of publication, when undertaking a screening assessment for a Habitats Regulation Assessment, of particular relevance is the '[People Over Wind judgement](#)'⁶ (Court of Justice of the European Union, 12 April 2018), the '[Dutch Nitrogen](#)'⁷ case (Court of Justice of the European Union, 7 November 2018) and other recent relevant Court of Justice judgements. Therefore, when developing your local plan update, you need to work with your legal team to ensure that you are familiar with relevant case law and Ministerial Statements and take account of these as and when appropriate.

You should also be aware that any reference to specific legislation includes any amendments to those instruments that are in force at the time of publication. Legislation relevant to England, including amendment regulations, can be accessed online at www.legislation.gov.uk. It is important that you check for any future amendments that may be brought into force following publication of this toolkit.

How to use the results of this part of the toolkit

You can use the results of this tool throughout the plan making process to ensure that requirements are met. There is no requirement to publish or submit this table to the Planning Inspectorate as part of the independent examination, but you may find it (or some elements) helpful to include with your supporting documents or to help you answer any questions from the Planning Inspector related to plan process.

The new NPPF was published on 12 December 2024. As well as changes to the Development Management process, changes with implications for plan-making included: • Raising the national target for housebuilding from 300,000 to 370,000 per year. • Revisions to the Standard Methodology for calculating housing need so that it is based on the stock of existing housing and uplifted by an affordability multiplier based on local circumstances. 						which states that the change is justified as it removes five years of historic development from the Plan and ensures that the Plan is forward looking. It also better aligns with the timing of the introduction of the new standard method housing need figure. As a consequence, the strategic policies within the Plan now only look ahead over a 13-year period from the anticipated date of adoption, rather than 15 years. This was discussed with PCC's advisory Inspector, who wrote that 'Rebasing the start of the plan period to 1 April 2025 is justified and reflects that the standard method is forward looking.' Every year, the Council produces an Authority Monitoring Report⁹ (AMR), which is published on the Council's website to monitor the implementation of The Portsmouth Plan Core Strategy (adopted 2012) and other development plan documents. This contains an update on national changes. The PLP is evidenced by a number of iterative versions of the Sustainability Appraisal (SA) and Habitat Regulations Assessment (HRA). The PLP 2024 and PLP Addendum 2025 are informed by a number of evidence base studies commissioned by the Council and published on the Council's new Local Plan evidence webpage¹⁰. Evidence base work for the new Local Plan (LP) commenced in 2016 as part of the new Local Plan review.

						Supporting evidence base studies are consistently kept under review to support and keep up to date the matters affecting the development of Portsmouth. The final evidence base can be viewed on the PLP Core Document Library webpage. For example, in 2023, the Council commissioned an updated Housing and Economic Development Needs Assessment (HEDNA) to reflect the plan period of 2020-2040 to ensure the Pre-Submission (Regulation 19) PLP 2024 was based on the latest evidence and conducted post-Brexit and the Covid-19 pandemic. The Council has again commissioned a targeted HEDNA update in 2025 to support the Local Plan Addendum policies on housing and employment targets and respond to NPPF 2024 changes. The Council commissioned an updated Retail Needs Study published in 2024 updating the existing retail and town centres evidence base study, the 2015 Portsmouth Retail Study and the 2020 Portsmouth City Masterplan Retail Focus Statement. This evidence base update was required to reflect the impact on the retail market and town centres of the Covid-19 pandemic in 2019; reform to the Use Classes Order revoking the old Use Classes B1, A1-A5, D1 and D2 and introducing the new Use Classes E, F.1 and F.2; and new permitted development rights allowing the change of use of buildings in Commercial, Business and Service (Class E) use to residential. PCC's decision to prepare a version of Policy PLP3: Tipner West for the PLP Addendum 2025 that does not result in adverse impacts on international conservation

						designations that cannot be mitigated has necessitated an update to a number of evidence-based studies including the HEDNA on development needs and the Housing and Economic Land Availability Assessment (HELAA) on the supply of development sites for the new plan period of 2025-2040. These support new Addendum policies on housing (PLP16) and employment (PLP25) targets in the PLP Addendum 2025. This is in addition to updates necessitated by the new NPPF, including changes to the Standard Method.

						2025 and PLP4 Tipner East in the Pre-Submission Local Plan). The review of the LP began in July 2017, following the Cabinet decision to commence the Local Plan review and updating process, and undertake public consultation on the Portsmouth Local Plan Issues and Options document under Regulation 18 of the Town and Country Planning (Local Planning) (England) Regulations 2012¹⁸. This was the first stage in preparing the new draft PLP, setting out the vision and issues for the City and the options to address them. Following the Issues and Options consultation, the emerging PLP has undergone an additional three consultations. This included a further two Regulation 18 stage consultations to inform the final version of the Pre-Submission Local Plan: • Local Plan Evidence Base Update¹⁹ (2019). This provided an update on the Council's evidence gathering for key issues in the draft LP. The responses to this consultation informed the development of the Portsmouth Local Plan 2038 Regulation 18 Consultation Document. • Tipner Strategic Development Area²⁰ (2019). This consultation focused solely on the Tipner Strategic Development Area. It set out the issues and possible options for the regeneration of Tipner and Horsea which included the

						reclamation of land from Portsmouth Harbour and aimed to identify where further work was required for the evidence base, to establish the appropriate site boundary and land uses at Tipner. • Portsmouth Local Plan 2038 Regulation 18 Consultation Document²¹ (2021). This document formed a new initial draft plan, setting out the draft vision and objectives for the development of the City up to 2038, and the proposed approach to strategic planning issues and development management in Portsmouth. The responses to the Tipner Strategic Development Area consultation fed into the three options proposed in this Regulation 18 plan. This Regulation 18 consultation also forms the basis of the Regulation 22 Consultation Statement²². All of the responses received in the four Regulation 18 consultations were analysed and helped inform the final version of the PLP for Pre-Submission (Regulation 19). The draft Pre-Submission Local Plan 2024²³ was consulted on between July and September 2024. The responses to the consultation will be summarised in the Regulation 22 Consultation Statement that will be published and submitted along with the Local Plan for examination.

						Particular delays to the Local Plan review and update have arisen due to the Tipner site, which has a complex planning history and numerous constraints including international nature conservation, flooding, contaminated land and heritage. The 2017 Issues and Options document proposed development of three strategic sites - Tipner West, Tipner East, and Tipner Firing Range. This allocation was largely supported at consultation²⁴, and further work was required to determine the appropriate proposals and way forward for the area. Tipner West has previously been partly allocated along with Tipner East in The Portsmouth Plan (2012). Following the 2017 consultation, a Tipner-focussed consultation (Tipner Strategic Development Area consultation) in 2019 put forward a number of options for development at Tipner. One option proposed was for significant land reclamation in a 'super peninsula' proposal ('Lennox Point'), which received strong objections from the Hampshire and Isle of Wight Wildlife Trust and the RSPB due to direct loss of SPA/Ramsar habitat. The responses to this consultation fed into the three options (Super-peninsula - significant land reclamation; no reclamation; maintain in current condition) proposed in the Portsmouth Local Plan 2038 Regulation 18 Consultation Document²⁵ (2021) for Tipner. The super-peninsula option involved reclamation of a considerable amount of land from Portsmouth Harbour, which is protected by multiple

						nature conservation designations. A significant amount of opposition to development at Tipner was received from this consultation, particularly towards Option 1 (significant reclamation). In December 2021, a report²⁶ (minute 105) containing a summary of the Tipner West and Horsea Island East project and summary of the Regulation 18 Consultation outcomes was presented to Cabinet and then to Full Council, who resolved to pause all further work on the 'super peninsula' (Lennox Point) Option 1 to allow for consideration of alternative options and financial viability. This consequently paused work on the Local Plan, with work to update the Local Plan only able to resume once the development proposals for Tipner West were resolved. In October 2022, following further assessment, all existing options for Tipner West were discounted and a set of guiding principles for an alternative option were agreed by Full Council²⁷. This included the ruling out of the 'Significant Land Reclamation' Option (Option A) - original 'Lennox Point' masterplan and 'Do Minimum' Option (Option D), allowing work on the Tipner West and Horsea Island East strategic site allocation (PLP3) and the wider Local Plan to resume and progress forwards. These guiding principles were updated in October 2023²⁸ and the seven Council principles confirmed in March 2024²⁹.

						The Pre-Submission Local Plan 2024 proposed the allocation of the strategic site of Tipner West & Horsea Island East under Policy PLP3. It was known that the allocation could not be delivered without some adverse effects on the international conservation designations of Portsmouth Harbour. Therefore, PCC as the local planning authority and competent authority could not give effect to the Local Plan under the Habitat Regulations unless the Government as appropriate authority notified them that they could do so. The City Council considered it prudent in terms of plan making to seek an Opinion from the Government, as appropriate authority under the Habitats Regulations, asking whether IROPI existed to justify the allocation. Two separate requests were made: the first response received in 2023 was that the request was premature and the second response in February 2025 was negative. The second opinion was withdrawn (because the Secretary of State agreed it was unlawful) shortly afterwards, and a new Opinion was issued in July 2025. The July 2025 Opinion was unlawful and also withdrawn. At the time of writing PCC is awaiting a lawful IROPI Opinion. Notwithstanding the City Council's view that the Secretary of State's IROPI opinions were both unlawful, the City Council decided, on a pragmatic basis and cognisant of the pressing 12 June 2026 deadline for submission of a Local Plan for examination, to prepare a version of Policy PLP3 that had no adverse impact on internationally designated sites that cannot be mitigated through a Local Plan Addendum. This has consequently resulted in PCC reducing development proposals for PLP3:Tipner West including the removal of the former

						proposal to deliver a strategically significant marine hub. This was agreed by Cabinet in April 2025³⁰. The PLP has been identified in the Portsmouth Local Development Scheme³¹ (LDS), which is a timetable for the production of Portsmouth's planning policy documents. The LDS has been updated throughout the preparation of the Local Plan with the first LDS including the new Local Plan published in 2017. The latest version of the LDS came into effect on 30 April 2025. Section 5 of the LDS relates to the monitoring and reviewing of development plan documents.

The SCI was a review and update to its previous version³² adopted in June 2017. The Council has recognised that a refresh of the SCI was required due to significant changes in the way that the Council and communities interact, including through greater use of online communications. The SCI explains how residents and businesses can take part in the process of developing planning policy and managing new development in Portsmouth. Section 5 of the SCI relates to the monitoring and review of the SCI.

						In July 2017, the Council prepared a report⁵³ for Cabinet to commence the Local Plan review process. This review sets out eight objectives for achieving the Portsmouth Vision 2034 as well as the principal policy areas to be considered, including housing, employment and retail, health, heritage and the environment. The Council consulted on the topics to be addressed in the new LP under the Issues and Options Consultation⁵⁴, which was the first stage of the Local Plan review. It set out the Council's vision for the City's development, the issues facing the City and the Council's proposed approach or options to address them. In February 2019, the Council launched two consultations: the first being the Local Plan Evidence Base Update which provided an update on evidence gathering for the LP and the second being the Tipner Strategic Development Area Consultation Document⁵⁵, which set out the issues and possible options for the regeneration of Tipner and Horsea. This included the reclamation of land from Portsmouth Harbour and identified where further work was required for the evidence base to establish the appropriate site boundary and land uses at Tipner. The responses to this consultation fed into the three options proposed in the Portsmouth Local Plan 'Regulation 18' consultation draft document⁵⁶. This was approved by Cabinet in July 2021 for public consultation⁵⁷, and consulted upon in

The supporting evidence for the Plan was further developed to include the preparation of commissioned studies, engagement with neighbouring authorities and an updated appraisal of all potential development land in the City (including a 'call for sites'). Subsequently, the responses to the Regulation 18 consultations have developed and reshaped the scope of the Regulation 19 Pre-Submission Local Plan 2024, to respond to developing local issues and ensure it is underpinned by relevant and up-to-date evidence. Additional evidence updating and gathering has taken place since 2021, as well as the addition of new site allocations in the Pre-Submission PLP 2024. Engagement between the Council and the legally described bodies is ongoing as part of the preparation of

One area in which the Council has considered this is in relation to its HRA. As set out above at Q26, the HRA process has been iterative, commencing with a screening assessment at the Issues and Options stage in August 2017 and proceeding through full HRAs produced at the Regulation 18 (August 2021) and Regulation 19 (April 2024 and September 2025 stages. Each iteration has responded to previous consultation responses. Policy PLP3:Tipner West and Horsea Island East strategic site allocation as proposed in the Pre-Submission Local Plan 2024 required a derogation from the Habitats Regulations. This required three tests to be met as set out in regulations 107 and 109 of the Conservation of Habitats and Species Regulations 2017 ('the Habitats Regulations'). To provide reassurance in relation to the first two of those tests, the Council sought an opinion from the Secretary of State under regulation 107(3) of the Habitats Regulations ('the IROPI opinion'). The Council first submitted such a request in April 2023¹⁵³. In September 2023, a response was received from DHLUC¹⁵⁴ stating it could not at that stage provide the IROPI opinion as PCC as the plan-making authority must first be satisfied there are no alternative solutions.

						Therefore, an opinion could not be given in advance of a finalised alternatives assessment, a completed assessment of the implications of the plan for the integrity of the sites concerned, and a proposed compensation strategy. In October 2024, the Council resubmitted its request for the IROPI opinion, accompanied by the Regulation 19 HRA and other supporting documents¹⁵⁵. The Secretary of State's first IROPI Opinion, received in February 2025, was negative but on account of legal errors in the Opinion, it was withdrawn by the Secretary of State. The second IROPI Opinion, received at the end of July 2025, was also negative and was also withdrawn. Notwithstanding the City Council's view that the Secretary of State's IROPI opinions were both unlawful, PCC decided, on a pragmatic basis and cognisant of the pressing 12 June 2026 deadline for submission of a Local Plan for examination, to prepare a version of Policy PLP3 that had no adverse impact on internationally designated sites that cannot be mitigated against, through a Local Plan Addendum. As stated above, the Addendum contains a new draft policy PLP3:Tipner West, which replaces the policy in the Pre-Submission Local Plan 2024 for PLP3: Tipner West & Horsea Island East. The new draft policy has been amended so that there are no adverse effects on the integrity of an internationally designated site that
