

THE PORTSMOUTH CITY COUNCIL (VARIOUS ROADS) (DISABLED PERSONS PARKING PLACES AND AMENDMENTS) ORDER 2025

The Portsmouth City Council (hereinafter referred to as "the Council"), in exercise of the powers under Sections 1, 2, 32 and 35 of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, of all other enabling powers, after consultation with the Chief Office of Police in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

CITATION

1. This Order may be cited as The Portsmouth City Council (Various Roads) (Disabled Persons Parking Places) Order 2025 and shall come into operation on the **8 December 2025**

INTERPRETATION

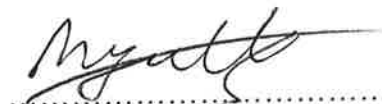
2. In this Order:
 - (I) "Principal Order 1" shall mean The Portsmouth City Council (Disabled Persons Parking Places) (Consolidation) Order 2022, as amended
 - (II) "Principal Order 2" shall mean The Portsmouth City Council (Consolidation) (On Street Parking Places and Restrictions on Parking and Loading) (No 1) 2022
 - (III) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (IV) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

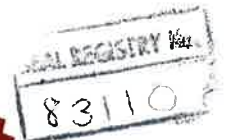
AMENDMENTS

6. The contents of Schedule 4 shall be added to schedule 1 to Principal Order 2

Road	Side	Description
Curzon Howe Road	West	From a point 1 metre south of the property boundary of No.12 and No.14, for a distance of 5.5 metres in a southerly direction
Delamere Road	North	From the western property boundary of No.13, for a distance of 5 metres in an easterly direction
Devon road	West	From a point 2 metres south of the northern property boundary of No.39, for a distance of 6 metres in a southerly direction
Kenyon Road	East	From a point 5 metres south of its junction with Mayfield Road, for a distance of 5,5 metres in a southerly direction
Mayfield Road	South	From a point 54 metres east of its junction with Kensington Road, for a distance of 5.5 metres in an easterly direction
New Road	South	From a point 29 metres west of its junction with Copnor Road, for a distance of 5.5 metres in a westerly direction
Newney Close	East	From the northern property boundary of No.15, for a distance of 3.6 metres in a southerly direction and 5.5 meters in a westerly direction
Powerscourt Road	South	From the eastern property boundary of No.358, for a distance of 5 metres in a westerly direction
Purbrook Road	North	From the western property boundary of No.25, for a distance of 5 metres in an easterly direction
Queens Road	North	From the western property boundary of No 289, for a distance of 5.5 metres in an easterly direction

Stanley Avenue	South	From the eastern property boundary of No.36, for a distance of 5.5 metres in a westerly direction
Station Road	West	From the northern property boundary of No.2, for a distance of 5.5 metres in a southerly direction
Tarleton Road	West	From the southern boundary of No.14, for a distance of 5.5 metres in a northerly direction
Winchcombe Road	South-west	From a point 2 metres north-east of the southern property boundary of No.39, for a distance of 5 metres in a north-easterly direction

SCHEDULE 3 - Waiting Restrictions (Deletion)

Delete from Schedule 1 to Principal Order,
1176. Station Road, Copnor

- (c) The north side from a point 3 metres west side in an easterly direction for a distance of 7 metres

SCHEDULE 4 - Waiting Restrictions (Addition)

Insert into Schedule 1 to Principal Order,
1176. Station Road, Copnor

- (c) The north side from its eastern kerb line, for a distance of 3.5 metres in a westerly direction
- (d) The west side from its northern kerb line, for a distance of 4.7 metres in a northerly direction
