

**THE PORTSMOUTH CITY COUNCIL (VARIOUS ROADS)
(DISABLED PERSONS PARKING PLACES) ORDER 2025**

The Portsmouth City Council (hereinafter referred to as “the Council”), in exercise of the powers under Sections 1, 2, 32 and 35 of the Road Traffic Regulation Act 1984 (“the 1984 Act”), as amended, of all other enabling powers, after consultation with the Chief Office of Police in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

CITATION

1. This Order may be cited as The Portsmouth City Council (Various Roads) (Disabled Persons Parking Places) Order 2025 and shall come into operation on the **30 March 2026**

INTERPRETATION

2. In this Order:
 - (I) "Principal Order" shall mean The Portsmouth City Council (Disabled Persons Parking Places) (Consolidation) Order 2022, as amended
 - (II) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (III) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

3. The contents of Schedule 1 shall be deleted from Schedule 1 to the Principal Order
4. The contents of Schedule 2 shall be added to Schedule 1 to the Principal Order

Dover Road	West	From the property boundary of No. 177 and No.179, for a distance of 5.5 metres in a southerly direction
Eldon Street	West	From a point 9 metres south of its junction with Sackville Street, for a distance of 5 metres in a southerly direction
Elkstone Road	North-east	From the property boundary of No. 44 and No.46, for a distance of 6 metres in a southerly direction

Kirby Road	South	From the property boundary of No.118 and No.120, for a distance of 5.5 metres in an easterly direction
Locarno Road	North	From a point 23 metres west from the eastern property boundary of 64 Aylen Road, for a distance of 5.4 metres in an easterly direction
Morgan Road	East	From the property boundary of No.5 and No.7, for a distance of 5.5 metres in a southerly direction
New Road	South	From the property boundary of No.192 and No.194, for a distance of 6 metres in an easterly direction.
Newcomen Road	North	From a point 9 metres west from its junction with Stamshaw Road, for a distance of 5.5 metres in a westerly direction
North End Avenue	South	From a point 0.9 metres west from the western property boundary of No.55, for a distance of 5.5 metres in an easterly direction
Prince George Street	North	From a point 43 metres of its junction with Cross Street, in an easterly direction for 5 metres
St Piran's Avenue	East	From the property boundary of No.21 and No.23, for a distance of 5 metres in a southerly direction
Sun Street	South-east	From a point 6 metres south-east of its junction with Britain Street, for a distance of 5 metres in a south-easterly direction
Tokar Street	South	From a point 21 metres east of its junction with Morley Road, for a distance of 5 metres in an easterly direction
