

THE PORTSMOUTH CITY COUNCIL (TANGIER ROAD) (PARKING PLACES AND WAITING RESTRICTIONS) ORDER 2025 (P017-2025)

The Portsmouth City Council (hereinafter referred to as "the Council"), in exercise of the powers under Sections 1, 2, 32, 35 and 45 of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, of all other enabling powers, after consultation with the Chief Office of Police in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

CITATION

1. This Order may be cited as The Portsmouth City Council (Tangier Road) (Parking Places and Waiting Restrictions) Order 2025 and shall come into operation on the 4 May 2026.

INTERPRETATION

2. In this Order:
 - (I) "Principal Order" shall mean The Portsmouth City Council (Consolidation) (On-street Parking Places and Restrictions on Waiting and Loading) (No.1) Order 2022, as amended
 - (II) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (III) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

3. The following paragraph shall be added as a new Article 25A to PART III SECTION A of the Principal Order:

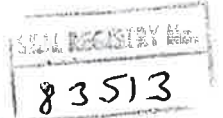
"No person shall cause or permit any vehicle to wait between the hours of 8am and 6pm, Monday to Sunday in the roads, sides of roads and sides of lengths of roads specified in Schedule 85A for a period longer than 4 hours, or if a period of less than 4 hours has elapsed since the termination during the said hours of the last period of waiting of the vehicle (if any) in the parking places specified in Schedule 85A
4. The contents of schedule 1 shall be added to Schedule 1 to the Principal Order
5. The contents of Schedule 2 shall be deleted from Schedule 1 to the Principal Order
6. The contents of Schedule 3 shall be added to Schedule 18 to the Principal Order
7. The contents of Schedule 4 shall be added as a new Schedule 85a to the Principal Order

SCHEDULE 1

Insert into Schedule 1 to Principal Order, Item 1207. TANGIER ROAD

(b) The north side;

- (xiii) from a point 5 metres east of the eastern boundary of No.263 in an easterly direction for a distance of 35 metres
- (xiv) from a point 7 metres east of the access road to No.265 in a westerly direction for a distance of 118 metres
- (xv) from a point 9 metres west of entrance to children's home in a westerly direction for 14 metres
- (xvi) from a point 72 metres east of entrance to children's home in an easterly direction for 32 metres

(d) The south side;

- (vi) from a point 15 metres east of the projected eastern property boundary of No.264 in a westerly direction for a distance of 55 metres
- (vii) from a point 48 metres east of its junction with Stanley Avenue in an easterly direction for 125 metres

SCHEDULE 2

Delete from Schedule 1 to Principal Order, Item 1207, TANGIER ROAD

(b) The north side;

- (vii) from a point 5 metres east of its junction with the bus turning area in a westerly direction for a distance of 18 metres
- (viii) from the west side of its western junction with the bus turning area in an easterly direction for a distance of 12 metres

(d) The south side;

- (vi) from a point 313 metres west of its junction with Eastern Road in a westerly direction for a distance of 83 metres

SCHEDULE 3

Insert into Schedule 18 to Principal Order, Item 5. TANGIER ROAD

- (b) the north side, from a point 9 metres east of the eastern kerb line of access to children's home car park in an easterly direction for a distance of 49 metres
- (c) the south side, from a point 284 metres west of its junction with Eastern Road in a westerly direction for a distance of 29 metres

SCHEDULE 4

Insert as a new Schedule 85a to Principal Order

1. TANGIER ROAD

- (a) the north side from a point 7 metres east of the east side of Great Salterns car park access in an easterly direction for a distance of 63 metres
- (b) the south side, from a point 59 metres west of the western side of Sword Sands Path in a westerly direction for a distance of 69 metres
