

**THE PORTSMOUTH CITY COUNCIL (STAMSHAW LAKE CAR PARK)
(OFF STREET CAR PARK) ORDER 2025**

Portsmouth City Council in exercise of its powers under Sections 32 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, the Traffic Management Act 2004, and of all other enabling powers, after consultation with the Chief Constable of Police in accordance with Part III of Schedule 9 to the 1984 Act hereby makes the following Order:

CITATION

1. This Order may be cited as The Portsmouth City Council (Stamshaw Lake Car Park) (Off Street Car Park) Order 2025 and shall come into operation on the 3 August 2026.

INTERPRETATION

2. In this Order:
 - (I) "Principal Order" shall mean Portsmouth City Council (Off-Street Parking Places) (Consolidation) No. 58 Order 2022.
 - (II) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
 - (III) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

3. The contents of Schedule 1 shall be added to Schedule 1 to the Principal Order
4. The contents of Schedule 2 shall be added to Schedule 2 to the Principal Order

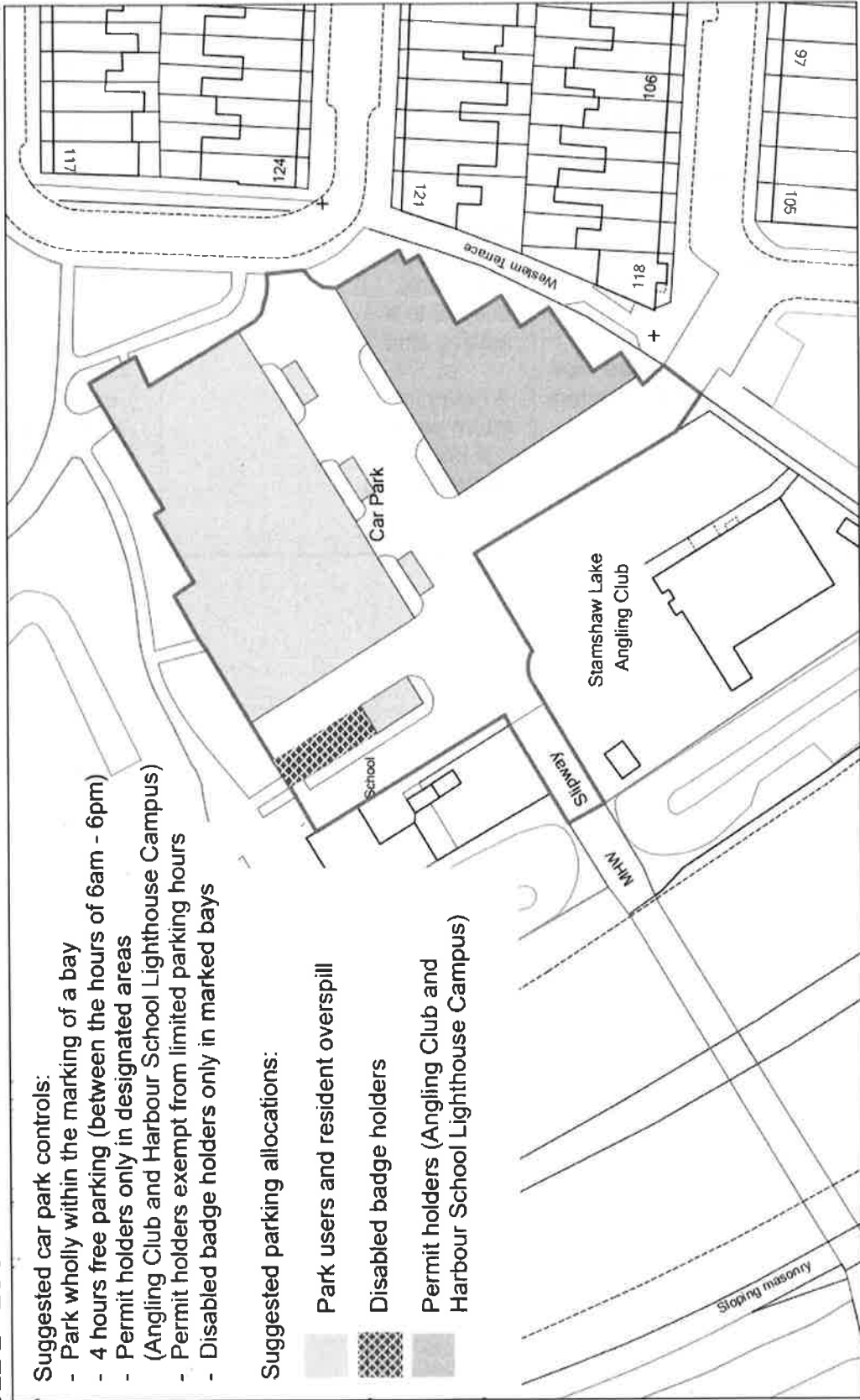
