

THE PORTSMOUTH CITY COUNCIL (HEWETT ROAD)

(WAITING RESTRICTIONS) ORDER 2026

The Portsmouth City Council (hereinafter referred to as "the Council"), in exercise of the powers under Sections 1, 2, 32, 35, 45 and 46 of the Road Traffic Regulation Act 1984 ("the 1984 Act"), as amended, of all other enabling powers, after consultation with the Chief Office of Police in accordance with Parts III and IV of Schedule 9 to the 1984 Act, hereby makes the following Order:

CITATION

This Order may be cited as **The Portsmouth City Council (Hewett Road) (Waiting Restrictions) Order 2026** and shall come into operation on the **DATE**.

INTERPRETATION

1. In this Order:

- (I) "Principal Order" No.1 shall mean The Portsmouth City Council (Consolidation) (On-street Parking Places and Restrictions on Waiting and Loading) (No.1) Order 2022, as amended
- (II) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
- (III) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

AMENDMENTS

- 2. The contents of Schedule 1 shall be added to Schedule 1 to the Principal Order.
- 3. The contents of Schedule 2 shall be added to Schedule 26 A to the Principal Order.
- 4. The contents of Schedule 3 shall be deleted from Schedule 1 to the Principal Order.

ARTICLES

- 5. The following shall be added as a new Article ~~(????)Schedule 26 A~~ to the Principal Order, Schedule 1, Part II, Section A Waiting and Loading Restrictions:

Schedule 26 A – "No Waiting" Monday to Saturday 6:00am to 5:00pm

" No person shall cause or permit any vehicle to wait between the hours of 6am and 5pm, Monday to Saturday including public holidays in the roads, lengths of roads, sides of roads and sides of lengths of roads specified in Schedule 26 A".

Schedule 1 - Addition

585. HEWETT ROAD

d) The south side:

From a point 1.5 metres east of the property boundary of Nos. 101 and 103
Hewett Road, for a distance of 20 metres in an easterly direction.

Schedule 2- Addition

1. HEWETT ROAD

- a) The north side:

From a point 1 metre east of the property boundary of Nos 99 and 101, for a distance of 33 metres in an easterly direction

Schedule 3 - Deletion

1. HEWETT ROAD

The south side from a point 81 metres west of its junction with Kensington Road in a westerly direction for a distance of 25 metres
